

## I Can Only Imagine Movie Sweepstakes

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the I Can Only Imagine Movie Sweepstakes (the "Sweepstakes") is open to legal U.S. residents (excluding Puerto Rico) who are 18 years or older and are physically located in the U.S. at the time of entry. Employees of Educational Media Foundation, dba K-LOVE ("Sponsor"), Renaissance Communications, Inc., and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. Text the daily keyword to 21947 to enter. All text messages must be received no later than 11:59 p.m. EST to count as a valid entry. Keywords cannot be provided over the phone, email, text message, social media or any other communication to K-LOVE.

For contests with text-message based entry, entrants will be asked through on-air announcements to provide certain information via a text message submission to the short code announced or otherwise stated during the contest. **Maximum one (1) entry per person and per keyword during Sweepstakes Period.**

No refund or compensation will be paid in the event of the cancellation or delay of the I Can Only Imagine movie premiere. Fandango promotional codes expires on 9/30/2018 or when "I Can Only Imagine" is no longer in theaters, whichever comes first. The terms and conditions of the promotional code may govern if the Trip/Event is cancelled due to weather, an act of God, an act of terrorism, civil disturbance or any other reason. Sponsor is not responsible for, and will not replace, lost, mutilated, or stolen Trip/Event tickets, vouchers, or certificates.

Limit: One (1) prize per person.

6. **Winner Notification and Acceptance.** Ten (10) potential winners will be notified on or about each day of the Sweepstakes Period via **the** telephone number used at the time of entry into the sweepstakes.

In order to claim a prize, potential winner must respond to Sponsor's notification within forty-eight (48) hours of notice or attempted notice.

Potential winners may be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law), which must be notarized and returned within forty-eight (48) hours of notification. Persons traveling as a guest of the Grand Prize winner may also be required to sign any affidavit or release that Sponsor requires.
