

## "You Got This" Flyaway Contest

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

2. **Eligibility:**

Subject to the additional restrictions below, the "You Got This" Flyaway (the "Contest") is open to legal U.S. residents (excluding Puerto Rico) who are 18 years or older and are physically located in the U.S. at the time of entry. Employees of Educational Media Foundation, dba K-LOVE ("Sponsor"), **PROVIDENT LABEL GROUP LLC** ("Prize Provider") and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. The term "family members" includes spouses, parents, grandparents, siblings, children, grandchildren and in-laws, regardless of where they live.

3. **Sponsor:**

This Contest is sponsored by Educational Media Foundation, dba **K-LOVE**, the decisions of the "Sponsor" regarding the selection of winners and all other aspects of the Contest shall be final and binding in all respects. Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials or announcements relating to the Contest.

All Contest entries become the property of **K-LOVE** and we may withhold any or all Contest entry materials for any reason station management deems crucial to the completion of the Contest or for reasons relating to publicity or advertising. Each entrant may enter a Contest only once, unless otherwise specified. In the case of multiple entries by the same person, all entries may be discarded, and the entrant disqualified.

Contest winners agree that they may be contacted by telephone and the call recorded for potential use on air. All calls to **K-LOVE** are taped and may be aired on **K-LOVE** without further permission.

4. **How To Enter:** The Contest will begin at **7:00 a.m. EST on July 11, 2019** the end date and time to be determined but no later than **12:00 a.m. EST on December 31, 2019** (the "Contest Period"). Sponsor will be the official timekeeper for the Contest.

On-Air contests consist of prizes being offered to participants selected on a random basis whereas a contest involves entrant participation and may require participants to use specific skills to solve or complete a specified objective in order to qualify for an award.

Listen to the Station weekdays between 7:00am EST and 11:30am EST for the K-LOVE Morning Show DJ to announce the cue to call in and be the designated numbered caller to the Station's contest line. The correct caller will be required to perform a task (i.e., answering a trivia question correctly), as determined by the Sponsor and announced during the cue to call to win.

The cue to plays announced may at times also be for a qualifying spot to participate in a Grand Prize Event or drawing. Listen to the Station for details on specific giveaways and for the times to play. The dates, times, and winner selection will vary with each station giveaway, as determined by the Sponsor and announced during the cue to call. If Sponsor determines the designated caller is not eligible, Sponsor may select the next consecutive eligible caller as the winner for that playtime.

Decisions of the Sponsor(s) are final. Listeners accessing Sponsor's radio station audio via IP connections like website-based streaming or mobile devices are welcome to enter. However, Sponsor cannot be responsible for delays in electronic transmission of station audio to IP devices. Listeners may be listening via the Sponsor's radio station stream on the Internet: please be advised that Listener may be listening to a delayed stream of the radio signal, which may vary depending on Listener's computer's memory capacity and the speed of Listener's internet connection and may be delayed by several minutes. Contest participants should not rely on streamed broadcasts in order to participate and Sponsor assumes no responsibility for Contest participants not making timely phone calls to the Sponsor's radio station as a result of the delays in the internet stream. By entering this Contest, listeners acknowledge and agree to this specific provision of these Official Rules. In addition, Sponsor will not be responsible for loss of service to the Contest Line or for a participant's failure to reach the Contest Line due to malfunction of any network or system, congestion, any technical or human error, failures or malfunctions of any kind, including the congestion, overload, busy signals, or any other factor that may prevent an individual from completing his/her phone call. In the event of interruption of power or telephone service to Sponsor during a call-in period of the Contest prior to accepting the designated caller, or a change in programming that results in Sponsor's inability to air a call-in opportunity, Sponsor will not replay the affected call-in opportunity and the number of Finalists opportunities awarded in this Contest will be reduced accordingly. If a designated caller is ineligible or fails to comply with any term of condition of these Official Rules, that caller will be disqualified, and no Finalist will be selected during that call-in period. Decisions of the Contest "sponsor" are final.

**Maximum one (1) entry per person during Contest Period.**

The use of multiple identities and/or accounts is prohibited, and any attempt to obtain more than the stated number of entries will void that participant's entries and may result in participant's disqualification. Incomplete, forged, altered, automated, mechanically-reproduced, lost, late, misdirected, garbled or illegible entries will be disqualified. Sponsor will not be responsible for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender, Sponsor, or Sponsor's Contest application service provider. In the event of a dispute, all entries will be deemed to have been submitted by the owner of the account from which they were sent, provided that such person satisfies all other Contest eligibility requirements. For these purposes, an account holder shall mean the natural person assigned to such account by the cell phone service provider, online service provider or other organization responsible for assigning cell phone numbers.

5. **Winner Selection and Odds:** On or about **July 11, 2019**, Sponsor will select one (1) potential Grand Prize Winner from among all eligible entries during the Contest Period.

**Odds of winning depend on the number of eligible entries received.**

6. **Prize Description:** Subject to verification of eligibility and compliance with these Official Rules, **one (1) Grand Prize Winner will receive round trip airfare for two (2) to attend a Casting Crowns show at a city to be determined (not to exceed \$2,000), 2-Night Hotel Stay for two, double occupancy, VIP seating and Meet & Greet at Casting Crowns concert.** Grand Prize Winner and guest must depart from one major US Airport and must select tour stop destination at least 14 days in advance of the date of claim. Prize Provider will determine airline, flight itinerary, and seating in its sole discretion. If Grand Prize winner cannot travel during the specified travel dates, then he or she forfeits the entire Grand Prize.

Trip/Event tickets are subject to certain terms and conditions as specified by issuer. The terms and conditions of the Trip/Event tickets may govern if the Trip/Event is cancelled due to weather, an act of God, an act of terrorism, civil disturbance or any other reason. Sponsor is not responsible for, and will not replace, lost, mutilated, or stolen Trip/Event tickets, vouchers, or certificates. Exact details, including seat locations, shall be determined in the sole discretion of Sponsor. Decisions of the Sponsor regarding Trip/Event are FINAL.

Limit: One (1) prize per person.

7. **Winner Notification and Acceptance:** Potential winners will be notified if they won the on air contest. Sponsor will contact winner within 48 of winning via the telephone number used at the time of entry into the Contest.

In order to claim a prize, potential winner must respond to Sponsor's notification within forty-eight (48) hours of notice or attempted notice.

Potential winners may be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law), which must be notarized and returned within forty-eight (48) hours of notification. Persons traveling as a guest of the Grand Prize winner may also be required to sign any affidavit or release that Sponsor requires.
