

K-LOVE 30 Days of Encouragement Sweepstakes
OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
2. Eligibility. Subject to the additional restrictions below, the K-LOVE 30 days of Encouragement Sweepstakes (the "Sweepstakes") is open to legal U.S. residents (excluding Puerto Rico) who are 18 years or older and are physically located in the U.S. at the time of entry. Employees of Educational Media Foundation, dba K-LOVE ("Sponsor"), and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. No donation is required to be entered into the sweepstakes. Individuals may enter one (1) time each week for the duration of the Sweepstakes. The dates that define each week are listed within the Prize Description section.

Multiple entries by means of software-generated or other automated processes will be disregarded. The use of multiple identities and/or accounts is prohibited, and any attempt to obtain more than the stated number of entries will void that participant's entries and may result in participant's disqualification. At the conclusion of each week, the electronic software used by the sponsor will automatically pull a potential winner from all eligible entries within the time period of that particular prizing. One winner will be selected for each week in a random drawing from among all eligible entries received during the Sweepstakes Period.

Odds of winning depend on the number of eligible entries received for each week

5. Prize Description. Prizes will be fulfilled approximately 2 weeks after the conclusion of the Sweepstakes

This data may be passed to a third party to enable such third party to fulfill any necessary requirements relating to
